
A total turnover of 9.849 billion shares worth N305.843 billion in 126,584 deals was traded this week by investors on the floor of the Exchange, in contrast to a total of 4.373 billion shares valued at N97.783 billion that exchanged hands last week in 110,736 deals.

The Financial Services Industry (measured by volume) led the activity chart with 8.295 billion shares valued at N232.223 billion traded in 50,351 deals; thus contributing 84.22% and 75.93% to the total equity turnover volume and value respectively. The Healthcare Industry followed with 517.443 million shares worth N3.472 billion in 2,979 deals. Third place was the Consumer Goods Industry, with a turnover of 392.765 million shares worth N12.664 billion in 18,438 deals.

Trading in the top three equities, namely Ecobank Transnational Incorporated Plc, First Holdco Plc and Access Holdings Plc (measured by volume), accounted for 6.424 billion shares worth N204.629 billion in 11,362 deals, contributing 65.23% and 66.91% to the total equity turnover volume and value respectively.




INDEX MOVEMENT
