<u>EQUITY</u>


A total turnover of 1.930 billion shares worth N20.656 billion in 24,687 deals were traded this week by investors on the floor of the Exchange, in contrast to a total of 1.541 billion shares valued at N18.235 billion that exchanged hands last week in 22,752 deals.

The Financial Services Industry (measured by volume) led the activity chart with 1.450 billion shares valued at N15.070 billion traded in 14,236 deals; thus contributing 75.11% and 72.96% to the total equity turnover volume and value respectively. The Conglomerates Industry followed with 154.906 million shares worth N179.673 million in 798 deals. The third place was Consumer Goods Industry, with a turnover of 111.782 million shares worth N2.270 billion in 3,865 deals.

Trading in the top three equities namely Wema Bank Plc, Zenith Bank Plc and First Bank Holding Plc (measured by volume) accounted for 782.167 million shares worth N8.914 billion in 4,624 deals, contributing 40.52% and 43.15% to the total equity turnover volume and value respectively.

INDEX MOVEMENT

The NSE All-Share Index and Market Capitalization depreciated by 0.96% to close the week at 39,799.89 and N20.823 trillion respectively.

Similarly, all other indices finished lower with the exception of NSE Banking, NSE AFR Bank Value, NSE MERI Growth and NSE Oil/Gas Indices which rose by 0.69%, 1.34%, 0.66% and 0.97% while the NSE ASeM and NSE Growth Indices closed flat. (See summary of index movements in the table below):



LASACO Assurance Plc: Completion of Share Capital Reconstruction

We refer to our market bulletin of 1 February 2021 with reference number: **NSE/RD/LRD/MB07/21/02/01**, wherein the Market was notified that trading in the shares of LASACO Assurance Plc (LASACO or the Company) was placed on full suspension effective Monday, 1 February 2021 as a result of the Company's proposed share capital reconstruction. Also refer to the subsequent extension of the suspension communicated to the Market through our market bulletin of 16 February 2021 with reference number: **NSE/RD/LRD/MB10/21/02/16**.

Dealing Members are hereby notified that the full suspension placed on trading in the Company's shares was lifted on Monday, 22 February 2021 following the completion of the share capital reconstruction. Consequent to the completion of the reconstruction exercise, LASACO's entire issued share capital of 7,334,343,421 ordinary shares of 50 Kobo each at ± 0.42 per share prior to the share capital reconstruction was delisted from The Nigerian Stock Exchange's (The Exchange) Daily Official List, while the 1,833,585,855 ordinary shares of 50 Kobo each at ± 1.68 per share arising from the share capital reconstruction were listed on The Exchange's Daily Official List on the same day.

With the completion of the Company's share capital reconstruction, the total issued and fully paid-up shares of LASACO Assurance Plc has now reduced from **7,334,343,421** to **1,833,585,855** ordinary shares of 50 kobo each.
