- **TAIFEX FTSE® 100 Index Futures to Be Launched on November 23<sup>rd</sup>**

TAIFEX is set to launch the FTSE® 100 index futures (F1F) on November 23<sup>rd</sup>. The new product is denominated in TWD and features small contract size, approximately TWD 300k (USD 10k) per contract, lowering the entry barrier and bringing higher capital efficiency. Also, its trading hours covers the regular trading sessions of the U.K. and the U.S. equity markets, enabling traders to hedge in real time. The other contract specifications, such as delivery months and final settlement price, resemble those of the FTSE® 100 index futures listed in Europe, creating inter-markets arbitrage opportunities. - **Trading Hours Extended for Expiring Contracts of U.S. Index Futures on the Last Trading Day**

Starting from November 23<sup>rd</sup>, the expiring contracts of TAIFEX's DJIA, S&P 500 and Nasdaq-100 Index Futures, can be traded in the after-hours trading session until 22:30 Taiwan Time (or 21:30 Taiwan Time during U.S. Daylight Saving Time), i.e., 9:30 New York Time, coinciding with the publication of the final settlement prices (Special Opening Quotations of the underlying U.S. equity indices). The extended trading hours allow traders to grab more trading opportunities and conduct timely position management.

- **Approval Granted For TAIFEX OTC Derivatives Clearing Operation Rules**

As the designated futures clearing house in Taiwan, TAIFEX has been planning to provide the centralized clearing service for OTC derivatives, and has recently received regulatory approval for its "Taiwan Futures Exchange OTC Derivatives Clearing Operation Rules." The new service aligns with international practices, aiming to reduce the counterparty risk in the OTC derivatives market, and mitigate systemic risk in the financial market in Taiwan.
